# Gask House Farm Holidays – Data Protection Policy

#### 1. Overview

Gask House Farm Holidays comply with the Data Protection Act 1998 (DPA), the General Data Protection Regulation (GDPR) and the Privacy and Electronic Communications Regulations (PECR). The GDPR came into effect on the 25th May 2018. This policy is reviewed and updated on an ongoing basis.

Gask House Farm Holidays collects and uses information (data) about our clients and bodies that our team have contact with; we follow the 8 principles outlined within the Data Protection Act 1998.

### 2. Principles of the Data Protection Act 1998

Personal information must:

- be fairly and lawfully processed.
- be processed for limited purposes.
- be adequate, relevant and not excessive.
- be accurate and up to date.
- not be kept for longer than is necessary.
- be processed in line with the date subjects' rights.
- be secure.
- not be transferred to other countries without adequate protection.

### 3. Sharing information with third parties

Gask House Farm Holidays shall not pass on your personal data to any third party. Please note how you booked your accommodation at Gask House Farm Holidays, third parties such as Airbnb may have access to your contact information as a result.

In certain circumstances, the Data Protection Act allows personal data to be disclosed to law enforcement agencies without the consent of the data subject. Under these circumstances, Gask House Farm Holidays will disclose requested data.

### 4. Your rights under the GDPR

Under the GDPR, you have a number of rights relating to your personal data and how it is processed. They are as follows:

- Right to be informed about the collection and use of your personal data.
- Right to access your personal data, and any supplementary information which constitutes personal data.
- Right to have your personal data rectified; this means you can ask Gask House Farm Holidays to correct your personal data if it changes, turns out to be inaccurate, or is incomplete.
- Right to have your personal data deleted; this means that you have the right to request the
  deletion or removal of your personal data. There are some circumstances when you do not have
  this right.
- Right to restrict Gask House Farm Holidays processing your personal data.
- Right to data portability.
- Right to object to Gask House Farm Holidays processing your personal data.
- Rights related to automated decision-making including profiling.

  decision-making including profiling) are not relevant to this business at the time of writing.

#### 5. The data we collect, how we use it and why

- Cookies and website visitor tracking small files installed in your browser that allow our website
  and many others to find out about your browsing behaviour. The purpose of Gask House Farm
  Holidays using cookies is to better understand visitors and improve their experience. This
  website has made use of a cookie notice that actively seeks confirmation of your acceptance or
  denial to the use of cookies.
- Guest contact information contact details are collected at the time of booking so that all
  visitors receive the information required ahead of their stay at Gask House Farm Holidays. This
  information is only stored for as long as necessary.
- E-newsletter mailing lists collected via e-newsletter subscription link.
   Prior to GDPR coming into force on the 25<sup>th</sup> May 2018, Gask House Farm Holidays have asked all subscribers to re-subscribe for the mailing list whereby they'll receive seasonal e-newsletters and updates. All previous mailing lists that were used prior to GDPR have been deleted.
- Social Media by following our Facebook, Instagram or other social media accounts, we process
  data based on your consent. This includes social media analytics which shows us the
  demographics of our followers, the information they find most interesting with statistics on
  reach and engagement.

#### 6. Your right to withdraw consent or update details

All individuals who are the subject of personal data held by Gask House Farm Holidays are entitled to:

- Ask what information the company holds about them and why
- Ask how to gain access to it
- Be informed how to keep it up to date
- Be informed how the company is meeting its data protection obligations

#### 7. Your right to lodge a complaint
